**1/. Back in 2016, 2019 and 2020 I informed you both YOU and through YOUR AMBASSADOR HERO MUSTAFA in Sofia – Bulgaria about the attempts to be ASSASSINATED BY ORDER OF THE MAFIA IN THE STATE OF MINISTER PRESIDENTS – BOYKO BORISOV, THE ORDER TO BE ASSASSINATED on 19.02.2020 by order of General LYUBEN GOTSEV BOYKO BORISOV, SOTIR TSATSAROV, and with the participation of the judges President of the Sofia City Court ALEXEY TRIFONOV and based on the falsified court minutes of a court session by Judge RAINA MARTINOVA of the Sofia City Court. All this was confirmed personally by General LYUBEN GOTSEV, who a few months before he died at the end of 2020, called me and asked for forgiveness for this order of his to be killed, because I had written about the MAFIA in the STATE with Prime Minister BOYKO BORISOV, about the mafia in the prosecutor's office with Chief Prosecutor Filchev, Associate Professor Boris Velchev, Sotir TsATSAROV, and others, about the mafia in the court, all courts, and the execution of ORDERS by the JUDGES and PROSECUTORS.**

**I hereby inform you of the ANOTHER ATTEMPT TO BE MURDERED on November 1, 2023 in a courtroom in the Sofia District Court building with the participation of JUDGE LYUBOMIR IGNATOV in a civil case in which I am a plaintiff against the Sofia Court of Appeals after I sued NELI KUTSKOVA, one of the mafia judges in a case with a construction company consultant, has recused herself after the company sent two people to intercede before the husband of Judge NULI KUTSKOVA, and in the same case of mine against the same construction company for STOLEN over 500,000 leva paid on December 21, 2007 to this company that did not transfer OFFICE number 5 to me, but transferred it to another company - practically stole from me, Judge NELI KUTSKOVA is not making a OWNERSHIP but deliberately confirms the replacement of the SECURITY that the same judge RAINA MARTYNOVA made secured by a property of the construction company, which will serve as security for my claim PROVEN by GRAPHOLOGICAL EXPERTISE at the PROSECUTOR'S OFFICE that the relevant money was there on 21.12.2007, REPLACES THIS SECURITY with only 5000 / five thousand / leva.**

**2. THE SCHEME and preparation of my murder on the incident of November 1, 2023 in front of and in the building of the Sofia District Court - the inconvenient questions and evidence**

**THE CASE:**

*In the court hearing on November 1, 2023 in a civil case in which I am a plaintiff in the Sofia District Court, I requested the disqualification of judge LYUBOMIR IGNATOV from the Sofia District Court, because he allowed himself to register in one of the minutes in a court hearing in the case - a previous hearing, ALL MY PERSONAL DATA EGN, ID CARD number, date of issue of the card, Ministry of Internal Affairs that issued the card and the address where I live.*

*Based on this, data from my ID card was leaked and there were raids on the COMMERCIAL REGISTER to steal companies that I represent.*

*Based on this, I have made two crises in connection with the fact that I am sick with LYMPH CANCER.*

*I stated to the judge LYUBOMIR IGNATOV that I have notified the prosecutor's office, the personal data commission and the KPOKNPI for his violations with my personal data.*

**HE GOT EVEN MORE ANGRY.**

**HE REFUSED TO LEAVE AND ASKED FOR MY ID CARD AGAIN, CLEARLY HE KNEW THAT I CHANGED MY ID CARD BECAUSE OF HIM.**

**I REFUSED to give him my ID card.**

**HE THREATENED ME THAT HE WOULD CALL THE POLICE TO FORCE ME TO GIVE UP MY ID CARD.**

**I DECLARED that I REFUSED TO PARTICIPATE IN SUCH A COURT SESSION IN SUCH A CASE, WHERE THERE ARE NO LAWS AND THE JUDGE IS PRESSING REPRESSION, FORCING ME..**

**I took my things and left.**

*I left the SRC building, and when I was outside the court building 7 / seven / meters away, suddenly the police officer YORDAN NIKOV and several other COURT SECURITY POLICE OFFICERS GRABBED ME BY THE HAND, BEGAN TO PUSH ME FORCEDLY TOWARDS THE BUILDING and FORCED ME TO ENTER THE SRC court building, to go up the stairs and FORCED ME INTO THE COURT HALL with judge LYUBOMIR IGNATOV. and FORCED ME TO GIVE MY IDENTITY CARD,. I GAVE MY IDENTITY CARD AND AGAIN JUDGE LYUBOMIR INATOV REGISTERED MY IDENTITY CARD EGN, ID card number, date of issue of my ID card and EVERYTHING ELSE.*

*IN THE HALL until the end of the court session around 2 hours and 55 minutes I WAS FORCED by the police to BE PRESENT in the courtroom. THERE WERE 5 / FIVE : COPS IN THE HALL WHO WERE LOOKING AT ME EVILLY. THE PERSON cop YORDANA NIKOV THREATENED ME, I even turned off the sound of one of my phones and HE THREATENED ME TO PUT MY PHONE IN.*

**THIS IS FASCISM – NEOLIBERAL NEOFASCISM.**

**NO ONE CAN FORCE ME TO GIVE MY IDENTITY CARD TO ENTER IT IN THE PROTOCOL WITH ALL DATA EGN NUMBER OF IDENTITY CARD, DATE OF ISSUE and Ministry of Interior.**

**NO ONE CAN FORCE ME TO BE PRESENT IN A COURT HALL IN A COURT CASE, CIVIL CASE IN WHICH I DO NOT WANT TO BE PRESENT.**

**MY BASIC RIGHTS HAVE BEEN VIOLATED. THIS IS FASCISM, NEOLIBERAL NEOFASCIC MAFIA.**

**THIS IS FORCEMENT TO WHAT I WAS SUBJECTED TO BY THE POLICE AND BY JUDGE LYUBOMIR IGNATOV.**

**3/. I was warned on 11/31/2023 that I WILL BE DETENTIONED and that there WILL BE AN ATTEMPT TO BE KILLED on 11/31/2023 and a few weeks before that, and I was told that JUDGE LYUBOMIR ANGELOV WILL BE USED and a case will be heard by him on 11/01/2023. EVERYTHING WAS PUBLISHED ON MY BLOG on the respective dates.**

**4/. EVERYTHING WAS PREPARED LONG BEFORE THAT.**

**Judge Lyubomir Ignatov when he CALLED ON THE PHONE from courtroom number 3 on the second floor of the SRC building on Tsar Boris Blvd. 3, AND CALLED COURT SECURITY.**

**HE DID NOT SAY MY NAME,**

**HOW DID THE POLICE - COPS KNOW WHAT I LOOK LIKE AND MY NAME since there were hundreds of people in the SRC building, only on the stairs there were over 18 people between the first and second floors.??!**

**WHERE AND HOW DID THE POLICE COPS KNOW WHO I AM AND THAT THEY SHOULD DETENTION ME PERSONALLY??!**

**. POLICE OFFICER YORDAN NIKOV, WHO FIRST DETENTED ME, AND AFTER THAT FOUR MORE POLICE COPS JOINED ME, AND SQUEEZED ME IN THE CORRESPONDING POINT IN THE LEFT SIDE OF MY ARM, WHICH IS PRETTY SICK, HE DID NOT SAY MY NAME, CLEARLY HE KNEW WHO I AM.**

**THIS WAS VIOLENCE, because at this point, THE OPPONENT IS NEUTRALIZED IMMEDIATELY. I DID NOT RESIST IN ANY WAY, BECAUSE YOU KNOW THAT THEY WOULD USE THIS AND KILL ME.**

**THERE ARE NO ACCIDENTS!!**

**THE SAME POLICE OFFICER YORDAN NIKOV NOT ONLY FORCED ME TO COURT HALL NUMBER 3 ON THE SECOND FLOOR OF THE COURT BUILDING, BUT ALSO FORCED ME TO TAKE OUT MY IDENTITY CARD AND PROVIDE IT TO THE JUDGE.**

**THE WHOLE TIME HE WAS STANDING NEXT TO ME 10 CENTIMETERS AWAY AND CONSTANTLY THREATENED ME, . SO I AM NOT A CRIMINAL.**

**AFTER THIS VIOLENCE UNDER THE PROTECTION OF THREE POLICE OFFICERS FOR TWO AND A HALF HOURS, I WAS FORCED TO BE IN HALL NUMBER 3 AND TO LISTEN TO AND PARTICIPATE IN A COURT HEARING, WHICH I REFUSED TO ATTEND A LONG TIME AGO, AND MY FREE WILL WAS REALLY VIOLATED, WHICH I EXPRESSED EXACTLY AND CLEARLY THAT I DO NOT WANT TO ATTEND THE COURT HEARING.**

**4/. I asked the President of the Sofia Court of Justice, Judge ALEXANDER ANGELOV, the Minister of Justice, Assoc. Prof. SLAVOV, and the Deputy Minister DECHEV, who is responsible for court security, to PROVIDE ME WITH THE RECORDINGS FROM THE THREE CAMERAS LOCATED OUTSIDE THE COURT BUILDING AND THE FOUR CAMERAS LOCATED AT THE ENTRANCE TO THE COURT BEHIND THE DOORS.**

**I REQUESTED TO BE ISSUED A CERTIFIED TRANSCRIPT of the RECORD OF THE ENTIRE COURT HEARING from the beginning at 11.30 am to the end, as well as the minutes of the court hearing held on November 1, 2023, as well as a COPY OF THE ENTIRE AUDIO RECORD of the COURT HEARING on November 1, 2023 under Case No. 20221110134611 - 150, panel of Judge LYUBIMIR IGNATOV.**

**I ASKED Deputy Minister DECHEV, a judge at the Sofia City Court with PROPERTY IN GREECE, to issue me a copy of the telephone conversation from courtroom number 3 on November 1 during the court hearing of the last cited civil case to the security of the SRC building on Blvd. Tsar Boris 3.**

**In connection with a signal submitted by me to the Minister and Deputy Minister DECHEV, I ASKED TO REQUEST RECORDINGS FROM THE CAMERAS that are installed in the building of the Sofia District Court Sofia, Tsar Boris Blvd. 3 as follows:**

**I ASKED RECORDINGS OF THE TWO CAMERAS THAT ARE LOCATED OUTSIDE THE TWO DOORS OF THE CENTRAL ENTRANCE OF THE BUILDING OF SOFIA, Tsar Boris Blvd. + AND LOOKING TO THE BULLETIN FOR THE TIME FROM 11.20 AM TO 1.30 PM ON 01.11.2023**

**I ASKED RECORDINGS FROM THE CAMERAS THAT ARE LOCATED AT THE CENTRAL ENTRANCE OF THE BUILDING OF THE SOFIA DISTRICT COURT, Tsar Boris Blvd. 23 FOR THE TIME FROM 11.20 AM TO 1.30 PM**

**I ASKED TO REQUEST CERTIFIED COPY OF THE REPORT prepared by the police in connection with my case on 01.11.2023.**

**I ALSO REQUESTED A COPY OF THE REPORT prepared in connection with the case. I AM SURE IT IS A FRAUD AND A DOCUMENT WITH FALSE CONTENT.**

**I ASKED, AFTER THEY FAMILIARIZED THE MINISTER, DEPUTY MINISTER AND PRESIDENT OF THE COURT OF JUDGES, WITH THE RECORDS FROM THESE CAMERAS - TO IMMEDIATELY DISCIPLINARILY DISMISS ALL THE COPS AND POLICEMEN WHO EXCEEDED THEIR RIGHTS, WHO KEPT ME OUTSIDE THE COURT OF JUDGES' BUILDING on Tsar Boris Blvd. 3, THEY FORCED ME OUTSIDE THE BUILDING AND FORCEDLY CONVOYED ME TO HALL NO. 3 ON THE SECOND FLOOR WHERE JUDGE LYUBOMIR IGNATOV WAS.**

**5/. SMALL LAW**

**In Art. 1 of the PDPA it is stated that it regulates the protection of individuals in the processing of their personal data, as well as access to such data. The purpose of the law is to guarantee the inviolability of the person and privacy, by protecting individuals in the event of unlawful processing of personal data relating to**

*them and regulating the right of access to such data collected and processed. The protection granted by the law is in principle not absolute and is subject to limitation in cases expressly provided for therein.*

*According to Art. Art. 170. (1) Before questioning the witness, the court shall establish his identity, clarify the data on his possible interest and remind him of his liability before the law in the event of perjury.*

*There is no such requirement for a party to a civil action.*

*The right to the protection of personal data is a fundamental right, the observance of which is an important objective of the European Union. It is enshrined in the Charter of Fundamental Rights of the European Union (hereinafter referred to as the "Charter"), Article 8 of which states: "1. Everyone has the right to the protection of their personal data. 2. Such data shall be processed fairly, for specified purposes and on the basis of the consent of the person concerned or on another legitimate basis provided for by law. Everyone shall have the right of access to data concerning him or her which have been collected and the right to have them rectified. 3. Compliance with these rules shall be subject to control by an independent authority"*

*According to the provision of Art. Art. 127. (1) The claim must be written in Bulgarian and contain:*

- 1. indication of the court;*
- 2. (amended - SG, issue 110 of 2020, effective 30.06.2021) the name and address of the plaintiff and the defendant, of their legal representatives or proxies, if they have any, an electronic address for service under the terms of Art. 38 and 38a and a statement as to whether he wishes service to be provided to the specified electronic address, as well as the telephone number of the plaintiff and his representatives or proxies, the plaintiff's uniform civil number and the fax and telex numbers, if any;*

*Therefore, there is no requirement anywhere in the Civil Procedure Code or any other law to enter data regarding the number, date of the personal card and these data are personal within the meaning of the Personal Data Protection Act. Although the court is an administrator of personal data, the Civil Procedure Code outlines the framework of the required data for the parties and the claimants, namely those under Art. 127 of the Civil Procedure Code - name, address, personal identification number, and other data is not collected.*

*Regarding the witnesses, the parties are asked to provide information regarding their citizenship in view of the provisions of Art. but not the ID card number, in view of the possible application of Art. 166 of the Civil Procedure Code and the right of certain persons to refuse to be witnesses.*

*Consequently, the court has gone beyond the powers and framework of the administrator and has violated the Civil Procedure Code, the Personal Data Protection Act, as well as international standards regarding personal data and is subject to sanction.*

#### **6/. HOW I WAS TO BE KILLED.**

**When I resisted, MY HEAD WAS TO BE PRESSED to the edge of one of the benches located on the second floor in front of the courtrooms. AND THAT ONLY FOR 15 SECONDS. ONLY 15 SECONDS GUARANTEE MY DEATH.**

In the same way, Plamen Penev was killed in the city of Stara Zagora, when police officers WITHOUT "wanting" to press his head with their hands to the edge of the sidewalk, which is 15 centimeters above street level.

**7/. Although I have requested the records from Minister Assoc. Prof. SLAVOV, Deputy Minister DECHEV with PROPERTY in GREECE, a copy of the records from the Chairman of the Sofia District Court Judge ALEKSANDR ANGELOV, from the prosecutors IVAN GESHEV, SOTIR TSATSAROV and Borislav SARAFOV, TO THE MOMENT no one has provided me with these records. FIRST LAWLESSNESS AND MAFIA.**

**DESPITE THE FACT THAT I REPORTED THESE IRREGULARITIES TO THE HIGHER JUDICIAL COUNCIL REGARDING THE LAWLESSNESS AND THE COERCION AND EXTORTION BY JUDGE LYUBOMIR IGNATOV, THE ENTIRE COMPOSITION OF THE HIGHER JUDICIAL COUNCIL AND THE INSPECTOR AT THE SJC DID NOT DO ANYTHING.**

**THIS IS A COMPLETE COVER UP A PROVEN MISDEMEANOR PERPETRATOR COMMITTED BY JUDGE LYUBOMIR IGNATOV COVER UP BY MINISTER AND DEPUTY MINISTER BY COURT PRESIDENTS OF THE COURTS OF THE SSR Aleksandar Angelov, by the Chairman of the SCC Judge RUSI ALEKSIEV, by the Chairman of the Supreme Court of Cassation DANIELA DONCHEVA, by the Chairman of the Supreme Court of Cassation Judge GALINA ZAKHAROVA, by the political parties GERB, DP PP, VAZRAZHDANE, MECH, BSP, DPS New Beginning and all those**

who are currently in parliament, all members of the HIGHER JUDICIAL COUNCIL, by the prosecutor's office - complete inaction.

**7/. THE MAIN REASONS FOR PREPARING OUR MURDER November 1, 2023**

**8/. CONFESSION** by General LYUBEN GOTSEV for his participation in the order for Momchil Dobrev to be killed on 19.02.2020

CONFESSON AND ATTEMPT TO ASK FOR A PARDON FROM THE BOSS OF THE MAFIA IN BULGARIA GENERAL LYUBEN GOTSEV – A FEW MONTHS BEFORE HIS DYING - THE REQUEST FOR A PARDON BECAUSE OF HIS ORDER TO KILL MOMCIL DOBREV, HIS AND THAT OF THE FORMER MINISTER BOYKO BORIS, UNDER PROSECUTOR SOTIR TSATSAROV, AND WITH THE SUPPORT OF THE PRESIDENT OF THE COURT OF THE COURT OF JURISDICTION ALEXEY TRIFONOV, AND SAZIA RAINA MARTYNOVA, THE PRESIDENTS OF THE COURT OF JURISDICTION DANIELA DONCHEVA, OF THE SUPREME COURT OF CASSATION LOZAN PANOV.

**7/. Other crimes committed by judge LYUBOMIR IGNATOV** of the Sofia District Court, supported by the chairmen ALEXANDER ANGELOV, RUSSI ALEXIEV, ALEKSEY TRIFONOV, LOZAN PANOV, GALINA ZAKHAROVA, DANIELA DONCHEVA and ministers and the entire composition of the Supreme Judicial Council.

**7.1/. Legalized crimes and mafia committed by judge NELI KUTSKOVA** from the Sofia COURT OF APPEALS, legalized by judge LYUBOMIR IGNATOV and BOGDAN RUSEV from the Sofia District Court

In civil case 34611 of 2022 according to the inventory of the Sofia District Court - 150th panel, judge LYUBOMIR IGNATOV REALLY WITH HIS DECISION LEGALIZED THE ACTIONS OF THE DOUBLE STANDARD OF JUDGE NELI KUTSKOVA from the Supreme Administrative Court which with the defendant THE SAME - the company " VMALKANOV AND MILANOV " WAS CONDUCTED IN ANOTHER CASE in which a person from the company contacted HER WIFE, but in the case my case against the JUDGE DEBTOR the company " VALKANOV AND MILANOV " IS NOT SHE HAS TAKEN AWAY AND DELIBERATELY CONFIRMED THE REPLACEMENT OF THE SECURITY OF THE FORBIDDEN PROPERTY WITH THE AMOUNT OF 5000 / FIVE THOUSAND / BGN AND PRACTICALLY GUARANTEED ME A LOSS OF OVER 1,000,000 / ONE MILLION BGN. AND THAT DESPITE THE CASE PROVING THAT THE COMPANY OWE ME FROM 21.12.20076. THE AMOUNT OF 75,500 BGN THAT I PAID FOR OFFICE NUMBER 5 WHICH WAS NOT TRANSFERRED TO ME BUT WAS TRANSFERRED BY THE COMPANY TO ANOTHER THIRD PARTY – AND IN FACT THE COMPANY HAS NOT RETURNED THE AMOUNT OF 75,500 BGN TO ME, AND HAS ACTUALLY REFUSED TO RETURN THE MONEY PAID TO ME.

DESPITE THIS INDISPUTABLE EVIDENCE, JUDGE NELI KUTSKOVA IS IMPLEMENTING DOUBLE STANDARDS AND JUDGE LYUBOMIR IGNATOV IS PUNISHING THE DOUBLE STANDARDS THAT ARE BEING APPLIED AGAINST ME AND MY COMPANIES WITH THE ULTIMATE GOAL OF LOSING MILLIONS OF LEV AS JUDGES LEGALIZED THE THEFT OF OUR INHERITANCE PROPERTY STOLEN BY EMIL KYULEV WITH FALSE NOTARIAL ACTS OF PROPERTY FOR OVER 600 MILLION EUROS IN THE CENTER OF SOFIA.

Despite the indisputable evidence of OBVIOUS MAFIA AND CORRUPTION PRACTICE committed by Judge NELI KUTSKOVA and the panel of the Sofia COURT OF APPEAL, JUDGE BOGDAN RUSEV from the Sofia DISTRICT COURT terminated the case against the Sofia Court of Appeal

**8/ In 2019 and 2020, with a letter to President TRUMP of the USA through Ambassador Hero Mustafa, President TRUMP was informed of the dozens of attempts on behalf of the mafia to assassinate Lord Acad. Prof. Momchil Dobrev after he proved the mafia, crimes in court, state, prosecutor's office in Bulgaria under the rule of Prime Minister BOYKO BORISOV, Prosecutor General BORIS VELCHEV and SOTIR TSATSAROV.**

#### **THE BEGINNING**

**It all started after 2008, the family of the Dobrev Dynasty Halachev refused to a criminal statesman designated as such by states, the USA, and other countries, at a high state level refused to give assets to the family at a price 90,000 times below the market price.**

**Death threats followed for Momchil Dobrev's father - Dobri Duchevo Dobrev managed three different industries during the socialist era and hundreds of enterprises in the field of mechanical engineering, the chemical industry, forklifts and transport machinery and made hundreds of millions of US dollars in the development of these industries, for which the socialist authorities headed by the state prime minister and first secretary of the Bulgarian Communist Party have many times wanted to THROW HIM IN PRISON BECAUSE HE RULED PROFITS LIKE A CAPITALIST.**

**After the threats of extortion and coercion in September 2008, Dobri Dubrev suffered a stroke and broke his hip in the hospital in the city of Burgas. He was immediately transferred to a hospital in Sofia by his son and underwent emergency surgery.**

**2010, by order of the Prime Minister BOYKO BORISOV and with the participation of a private bailiff Georgi Saykov Dichev, persons close to the mafia Krasimir Volov, other CHIs such as Ivan Cholakov and Nedyalka Kovacheva, and prosecutors Sotir Tsatsarov, Mariyana Stankova, Boyan Balev, tax audits were initiated by the National Revenue Agency, which sought only from Momchil Dobrev "unpaid taxes" as an individual 48 million leva, which is equivalent to the fact that he as an individual made over 4.8 billion leva - that much dollar turnover per year. The order of the then Prime Minister Boyko Borisov is carried out by the prosecutor's office, tax, and all services. This has been confirmed by various persons and most notably by General LYUBEN GOTSEV - the general of the mafia in Bulgaria.**

**After THREE YEARS OF RACKET AND FORCEMENT The National Agency for Privods comes out with audit reports that MOMCHIL DOBREV, DOBRI DUCHEV DOBREV do not owe a penny. Because of this racketeering and extortion, Momchil Dobrev is suffering from diseases, diabetes and other illnesses.**

**The murder attempts began in 2011 - setting fire to the apartment where Momchil Dobrev's parents live, while his father is in bed. They almost burn like TORCHES.**

**This was followed by January 2012 when a BUS was waiting for Momchil Dobrev at his office to crush him, and after Momchil's quick reactions, the bus just passed by and crushed one of his legs.**

**September 2012 at a trolley stop located in front of the Stock Exchange Commission, the entrance to which has three cameras, a person from the criminal contingent inflicted 17 blows with an umbrella handle on the left side of the face of Momchil Dobrev, who, with two full hands with two bags with two laptops, could not stand up.**

**NO ONE INVESTIGATES THE MURDER ATTEMPTS of Momchil Dobrev and until now 2025.. Since 2006 Momchil Dobrev informed the European Commission and the European Union about the MAFIA in the STATE AT THE STATE LEVEL with Minister President SERGEY STANISHEV, BOYKO BORISOV and Ministers of Justice Prof. Bliznashki, MARIN RAIKOV, and others about crimes, about the mafiaization of the court and the prosecutor's office which legalize the theft of properties, factories, for billions of euros of the Dobrev Halachev family.**

**After dozens more attempts to murder MOMCIL DOBREV.**

**September 2019 35 days Momchil Dobrev protested with posters in front of the courthouse in the center of Sofia with posters with evidence of the mafia in the court, with cited evidence of crimes of judges VALKOV, ALBENA BOTEVA, RAINA MARTINOVA, ALEKSEY TRIFONOV, ALEXANDER ANGELOV, LYUBKA GOLAKOVA, , Daniela DONCHEVA, Svetlin MIHAYOLEV Gerogi KOLEV,**

the President of the Supreme Court of Cassation LAZAN PANOV, Deputy President KRASIMIR VLAHOV.

The posters with evidence listed crimes of prosecutors of the Prosecutor General Ilchev Doc Velchev, of SOTIR TSATSAROV which prosecutors legalize crimes, thefts of private property worth billions of euros, factories worth hundreds of millions of euros, crimes committed by prosecutors stretched over criminals - judges, people of the mafia.

After this protest on behalf of the general, the boss of the mafia in BULGARIA, General LYUBEN GOTSEV and on his words said to Momchil Dzobrev three months before he died in 2020 on his behalf LYUBEN GOTSEV, BOYKO BORISOV, the Prosecutor General SOTIR TSATSAROV, with the participation of the judges, the chairman of the Sofia City Court ALEXEY TRIFONOV with two civil - Bulgarian and Russian, the judge RAINA MARTYNOVA, who falsified the court record and with 17 forgeries, is the 10th attempt to murder MOMCIL DOBREV on 19.02.2020, and this case will be described in another article.

In parallel, in 2015-2016, close to the Prime Minister BOYKO BORISOV and DELIAN PEEVSKI, the companies HYDROSTOY and VODSTORY 98 stole 2.9 million cubic meters of private land from the demes of the Dobrev Halachev dynasty and used them for the construction of the northern tangent of the capital Sofia. According to General GOTSEV BOYKO BORISOV and other individuals, the latter received a bribe of 50 million for this theft.

2023 Lord Academician Prof. MOMCHIL DOBREV in March 2023 filed a lawsuit in the New York District Court under the RICO ACT against the Prime Minister BOYKO BORISOV, the Prosecutor General SOTIR TSATSAROV, prosecutors, judges, and mafia companies involved in the theft of land for 130 million euros.

2020 Lord Acad. Prof. Momchil Dobrev and Lady Prof. Mariola Garibova-Dobreva publish another book to fight the MAFIA "RESTART OF BULGARIA - WITHOUT MAFIAISM in COURT, PROSECUTOR'S OFFICE, STATE. Theory of mafiaism by Prof. Momchil Dobrev " with hundreds of evidence of crimes by judges, prosecutors, statesmen, ministers, theft of hereditary properties for over 5 billion US dollars, by oligarch EMIR KYULEV owned by the Dobrev Halachev Dynasty, with false acts of municipal property issued by the mayors of Sofia SOFIANSKII, BOYKO BORISOV and FANDAKOVA, and the inaction of the current mayor of Sofia - TERZIEV --. Who does not want to fulfill the COURT DECISION THAT HAS ENTERED INTO FORCE and hand over the properties owned by the members of Dastia Dobrev Halachev - properties worth hundreds of millions of euros. Lord Academician Prof. Momchil DOBREV is the one who presents to the European Commission and the Union evidence of the mafia under various governments of Prime Ministers Saxe-Coburg-Gotha, Stanishev, Boyko Borisov and various acting Prime Ministers - Marin Raykov, Prof. Bliznashki, and dozens of others.

Since in the article we will discuss the judicial system according to **THEORY AND PRACTICE of FIRST BASIC LAW for MASTERING A STATE:**

**MASTERING THE JUDICIAL SYSTEM of this state.**

##### **1/. MASTERING THE COURT**

**STEPS FOR this mastering:**

1/. Appointment of judges loyal to the mafia in the court

2/. Appointment of prosecutors loyal to the mafia in the prosecutor's office

3/. CONTROL OF THE PROSECUTOR'S OFFICE

4/. CONTROL OF THE INVESTIGATION

5/. CONTROL OF THE MINISTRY OF JUSTICE

6/. CONTROL OF CONTROLLING BODIES IN THE JUDICIAL SYSTEM – for example, for BULGARIA - THE INSPECTOR TO THE HIGHER JUDICIAL COUNCIL

7/. CONTROL of the institution that appoints judges and prosecutors – HIGHER JUDICIAL COUNCIL – on the example of Bulgaria.

**16.4./. Control of the judicial system. Control of the court, Control of the prosecutor's office, Control of the investigation. Control of private judicial enforcement**

Control is achieved by appointing judges, prosecutors, investigators close to the mafia as heads of the courts, the prosecutor's office - the prosecutor general and the heads of regional prosecutor's offices, city, district prosecutor's offices.

Control of the judicial body - the Supreme Judicial Council

Control of the inspector to the judicial body - the inspectorate to the Supreme Judicial Council

Control of the Constitutional Court - appointment of constitutional judges persons close to the party oligarchy who carried out orders of the mafia

Control of the courts through the chairman of the Supreme Court of Cassation, the Courts of Appeal in Sofia, Plovdiv, Veliko Tarnovo, Varna and Burgas, control of the largest district court - Sofia City Court by appointing judges loyal and close to the mafia. Appointment of chairmen of the courts close to the mafia and the oligarchy, who will unconditionally carry out the orders of the mafia - to terminate cases, to lose cases against the mafia.

Mastering the system for appointing judges - ignoring, bypassing the electronic random selection system, as deputy chairmen and deputy chairmen of courts appoint a specific judge for a specific case, who will carry out the respective order of the mafia and the oligarchy.

Mastering the system for appointing judges for cases in the Supreme Court of Cassation - by appointing close chairmen of the Supreme Court of Cassation to people close to the mafia and respectively deputy chairmen of separate courts - civil, commercial, criminal, to appoint precisely defined judges for precisely defined cases, who will carry out the order of the mafia,

Mastering the system for appointing judges for cases in the Supreme Administrative Court by appointing close chairmen of the Supreme Administrative Court to people close to the mafia and respectively deputy chairmen of separate courts - civil, commercial, criminal, to appoint precisely defined judges for precisely defined cases, who will execute an order of the mafia.

**Creation of administrative courts to protect and legalize crimes committed by ministers, officials of state agencies, state services, ministries, against citizens, companies.**

**Creation of administrative courts to legalize repression, harassment, coercion carried out by the mafia through state institutions such as the National Revenue Agency, to condemn honest citizens who do not succumb to the mafia.**

**Appointment of mafia people as court presidents through which courts will:**

- Legalize the theft of private property by the mafia and the oligarchy
- Legalize the theft of money from mafia banks
- Indicate non-compliance with laws by banks serving the mafia
- Legalize non-compliance with laws by insurance companies serving the mafia

**DOUBLE STANDARD LAW - termination of lawsuits AGAINST BANKS, INSURANCE COMPANIES, COMPANIES, Ministries, State Commissions and State Institutions**

**. DOUBLE STANDARD LAW regarding the issuance of a decision.**

**DOUBLE STANDARD LAW – JUDGES ARE NOT RESPONSIBLE for the decisions they make**

**CREATION OF A SYSTEM FOR ENFORCING DOUBLE STANDARDS AND SCHEMES - THE NORM OF THE NEOLIBERAL NEOFASCIST MAFIA OF LAWLESSNESS and GENOCIDE OF LAW among JUDGES**

**CREATION OF A SYSTEM FOR SUPPORTING these WAR STANDARDS**
